Mahatma Gandhi National Rural Employment Guarantee Scheme – Project for Comprehensive Development of SC /ST Colonies - Guidelines and modalities -issued.

1. Instructions issued by MoRD, GOI under schedule 1 Para1 (ix) of MGNREGA, September 2011
2. Circular no. J-11060/1/2011-MGNREGA-I dt. 18.10.2011 of the MoRD, GOI. New Delhi.
3. Meeting held on 2.11.2011 in the chambers of the Commissioner, RD.

The works that could be taken up under the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) have listed in the schedule I of the Act. In accordance with the provisions of the Act, Ministry of Rural Development vide reference 1st read above, expanded the scope of works under schedule 1 Para 1 (ix) to include Access to Sanitation facilities. Further vide reference 2nd read above, internal roads (within the residential areas of villages) have been permitted with proper drainage system.

2. Commissioner Rural Development reported that there are demands from the Gram Sabhas held to identify the shelf of works to allow a comprehensive development of the backward habitations primarily inhabited by SCs and STs consisting of laying of roads with drainage and construction of Individual Sanitary Latrines. She proposed after detailed discussions with Chief Engineer, PR, Chief Engineer, RWS & S, Chief Quality Control Officer, NREGS, Technical Advisor, Rural Development, to permit taking up a project for overall development of all SC/ST colonies under the nomenclature "**Project for Comprehensive Development of SC /ST Colonies**".

3. Government after careful consideration, and to improve the general quality of life in the most backward areas, approved the proposal to take up a Project for comprehensive development of SC/ST colonies under MGNREGA subject to maintaining the wage, material ratio at 60:40 at the district level. The project shall be implemented in 3,294 SC/ST localities in 2011-12 and extended to all the SC/ST localities in the State by 2014. The project shall be implemented subject to the following modalities:

- a) Identification: In each Mandal, 3 SC/ST colonies which have the highest labour turnout in MGNREGS in 2011-12 (till November 2011) shall be selected for implementation in the 1st year.
- b) Coverage of works: The identified colonies shall have CC roads with drainage facility, Individual Sanitary Latrines for all houses on a saturation basis.
- c) Provision of Sanitation facilities to the colonies shall be implemented as a convergence project along with Rural Water Supply Department. Whereas Rs. 3,500 per ISL is provided through RWS department, an amount not exceeding Rs. 1,300/- can be booked under MGNREGS covering all the labour (unskilled and skilled) component. The project shall also include Construction of Anganwadi Toilets wherever sanctioned under TSC component, under which an amount of Rs. 2,000/- covering the labour cost (skilled and unskilled) can be spent from MGNREGS funds. AE/AEE, RWS&S department will be responsible for implementation and measurement of the work. The Deputy Executive Engineer, RWS&S shall check measure the work and payments will be made through the existing Mandal Computer Centers.
- d) Provision for Internal Roads and side drains: AE/AEE, PR department will be the Implementation Agency for giving technical assistance and measurement of the work. The Deputy Executive Engineer shall check measure the work and payments will be made through the existing Departmental Computer Centers of Panchayat Raj Engineering Department. The CE (PR) will monitor the overall project. At District level the existing DCC's (PR) will implement and monitor.
- e) All processes laid down under the Act shall be followed in identification and execution of the works.
- f) The District Collector shall ensure that the wage: material component ratio is maintained as 60:40 taking district as unit as per NREG Act provisions.

4. Under the Project, in the 1st Phase, 3294 SC/ST colonies in the state shall be developed in 2011-12 with a total budgetary provision of Rs 746.10 Crores under MGNREGS. The funds are available in the labour budget allocated to the State for 2011-12.

5. The Commissioner, RD shall issue detail guidelines for implementation of the Project. All the District Collectors are requested to issue administrative sanctions for the project before 31st December 2011. PDs, DWMA shall assist in identification of the localities, cause preparation of project reports, and assist District Collectors in due verification of the Project reports. 
