- 1** CATEGORY OF POST EDUCATIONAL QUALIFICATION
Village Revenue Assistant Must have passed **S.S.C (10th Class) Examination** conducted by the Andhra Pradesh State Board of Secondary Education or its equivalent Examination.

Shall be the Native of the Revenue Village for which the Recruitment is notified.
- 2** **AGE: -** The applicant should have completed (18) years of age as on 01-07-2011 and should not have completed (35) years of age as on the said date.
(in case of SC/ST maximum age limit shall be 40 years)
- 3** SCALE OF PAY :- Rs.3000/- Honorarium and other allowances as fixed by Government from time to time
- 4** **Selection :-**

 - The Selection of candidates is based on a objective type Written Test for 100 Marks at S.S.C., level.
General Studies : 60 Marks
Arithmetic Skills : 30 Marks
Logical Skills : 10 Marks
 - 50% of questions (30 Marks) will be aimed at testing the knowledge of the candidate on rural areas and rural living conditions.
